Eco-Arts and its agents can accept no responsibility for losses or additional expenses due to delay or changes in air or other services, sickness, weather, strike, war, quarantine, or other causes. All such losses or expenses will have to be borne by the passenger, as tour rates provide for arrangements only for the time stated. The right is reserved to substitute hotels of similar category for those indicated and to make any changes in the itinerary where deemed necessary or caused by changes in air schedules. The right is reserved to cancel any tour prior to departure, in which case full refund will constitute full settlement to the passenger. The right is reserved to substitute leaders on any tour. When this is necessary, notification will be given to tour members. No refund will be made for any unused portion of the tour unless arrangements are made in sufficient time to avoid penalties. The right is reserved to decline to accept or to retain any person as a member of any tour. Baggage is at owner's risk entirely.

Third party suppliers, who are independent of **Eco-Arts**, will provide travel services in connection with all tour packages. Such third party suppliers are exclusively responsible for providing services including transportation, lodging, meals, recreational activities, etc. Eco-Arts maintains no control over the operation, equipment or personnel of such suppliers and therefore assumes no liability or responsibility for any personal injury, property damage or other loss, accident, delay or inconvenience, caused & by any wrongful or negligent act or omission on the part of any service provider.

Travelers who need special assistance must report any disability requiring special attention to Eco-Arts at the time the reservation is made. Eco-Arts will make reasonable attempts to accommodate the special needs of disabled travelers, but is not responsible in the event it is unable to do so nor is it responsible for any denial of services by carriers, hotels, restaurants, or other independent suppliers. The Americans with Disabilities Act is only applicable within the United States and facilities for disabled individuals are limited outside its borders. Most transportation services, including the touring motorcoach, are not equipped with wheelchair ramps. We regret that we cannot provide individual assistance to a vacation participant for walking, dining, getting on and off motorcoaches and other vehicles, or other personal needs. A qualified and physically able companion must accompany travelers who need such assistance and must assume full responsibility for their well being.
